

## HOW TO EXERCISE YOUR VOTING RIGHTS

Registered holder: Any person who holds Common Shares registered in their name in the Bank's share register

**Beneficial owner:** Any person holding Common Shares registered in the name of a nominee (such as a securities broker, other intermediary, or a duly authorized agent) on his or her behalf

	Your intermediary must receive your instructions one business day before the proxy deposit date, <b>no later</b> <b>than April 21, 2020 at 5 p.m. (EDT).</b> Refer to the instructions on your Voting Instruction Form.

#### Vote online at the virtual meeting

#### OPTION 2 Vote online at the virtual meeting
